*** Pursuant to the June, 23, 2023 Order "Approving Financial Backstop Collection Mechanism," NYSERDA is approved to collect from the EDCs the accumulated ZEC Deficit of \$33,295,904 through year five of the ZEC program ending March 31, 2022. Commencing December 15, 2023, NYSERDA invoiced the EDCs quarterly, in four equal amounts equal in the aggregate to the cumulative deficit amount of \$33,295,904. As of 3/31/2024, \$24,971,928 remained to be collected from the EDCs.
